


Limitations of the CB IR and BIR



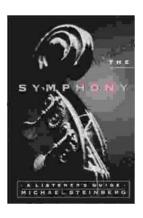
